## Candrian Catering AG takes over Clouds restaurant business in Prime Tower

Swiss Prime Site is handing over the renowned Zurich-based Clouds restaurant business to Candrian Catering AG as at the beginning of 1<sup>st</sup> July 2015. Swiss Prime Site is therefore concluding a successful expansion phase as well as signing a multi-year rental agreement with the new operator Candrian Catering AG.

In the wake of an intensive three-year expansion phase, Swiss Prime Site is exiting the restaurant operating business and focusing on its core activities, with investments in high-quality real estate and real estate-related fields of business. Clouds, situated on the 35th floor of Prime Tower, will be leased to Candrian Catering AG, Zurich, starting from July 2015. Swiss Prime Site has concluded a multi-year rental agreement with the restaurant and catering group.

Swiss Prime Site CEO Markus Graf: "We are handing over a successful and well-established restaurant business to Candrian Catering AG that is cherished and well frequented by guests far beyond the Zurich City limits. We are convinced that the new operator will continue to manage and further develop Clouds with the same sense of purpose."

Candrian Catering AG will maintain the Clouds brand and continue to manage the multifaceted gastronomy concept featuring restaurant, bar and bistro. Some conceptional adjustments are envisaged for the restaurant.

Candrian Catering AG CEO Reto Candrian: "We will continue to appeal to a broad customer segment and act as a professional host in Clouds as well. We aim to welcome our guests with the highest-quality, enduring hospitality and cordiality."

Swiss Prime Site had incorporated Clouds into its plans for the overall property site development from the outset and made Prime Tower accessible to the general public as well. After opening its doors in December 2011, Clouds quickly established itself at the pinnacle of the Zurich restaurant business, ever since serving as special attraction and beacon for the up-and-coming Zurich West urban quarter.
